ACTION: Michelle Williams will follow up with representatives from DC, PA and DE on updates to the Toxic Contaminants Research Workplan. Still open—need updates from DE. Will share updated workplan for April conference call.

ACTION: Status updates to the Toxic Contaminants Policy and Prevention Workplan will be incorporated into the Status document for the Policy and Prevention workplan.
