- ✓ Sept 2015 Nov 2015: Partnership briefings on draft Assessment Report
- ✓ **Sept 2015**: WQGIT Working Group formed to develop Action Plan
- ✓ <u>December 15, 2015</u>: WQGIT approved Assessment Report on behalf of partnership
- ✓ Feb 22, 2016: WQGIT approved Action Plan
- ✓ March 2016: Action Plan submitted to Management Board and Principals' Staff Committee for approval

## Purpose of Stakeholder Assessment

- Recommend improvements to the WIP development, evaluation, implementation, and oversight processes so that the Phase III WIPs create effective plans for implementation through 2025.
  - Identify lessons learned from Phase I and Phase II WIP processes that should be applied to Phase III WIPs in order to facilitate local engagement and implementation.

 Implementing the Chesapeake Bay TMDL and meeting applicable water quality standards in the Bay and its tidal rivers is our highest priority

### Stakeholder Assessment Action Plan

• **Purpose**: Translate assessment findings into actions to inform development of Phase III WIP expectations.

• Goals of Action Plan: Recommend specific steps the CBP partnership can take to address the 9 shared concerns, and how these actions can be used to build programmatic capacity at the state and local jurisdictional levels and inform opportunities for increasing local participation in the development of the Phase III WIPs.

## Action Plan's Guiding Principles

- One-size-fits all local engagement approach will not be effective
- Local concerns and priorities must be considered
- Outreach should include local staff AND elected officials
- Allow for creative and innovative solutions
- Utilize local knowledge systems to influence decision-making
- Local communication and outreach should begin early and consistently
- Adopt realistic time horizons for achieving goals between now and 2025
