- 1:15 <u>Approval of the 2013-2017 High-Resolution Land Use Change Data for CAST 2021</u> Peter Claggett, USGS (1hr.)

Peter Claggett will give an overview of the proposed decision to include the 2013 - 2017 high resolution land use change data in CAST 2021 to the WQGIT and ask for consensus.

*Decision Requested:* WQGIT consensus on the use of the high-resolution land use change data (2013-2017) as the "best available data" to inform CAST 2021.

2:15 <u>Setting Forest Buffer Credit Duration to 15 years in CAST 2021</u> – Sally Claggett, USFS/ FWG Coordinator and Vanessa Van Note, EPA- CBPO (30 min.)

Sally Claggett and Vanessa Van Note will give an overview of the rationale presented in the Forestry BMP Practice Life and Credit Duration paper. The Forestry Workgroup (FWG) is requesting that CBP approve a 15 year credit duration for all forest and tree planting practices. This is supported by the literature and, for agricultural forestry practices, is what was originally spelled out in the Forestry Verification Guidance. The FWG's proposal was presented to the BMP Verification Ad-Hoc Action Team in July, and received its support, with comments.

**Decision Requested:** WQGIT approval of a 15 year credit duration for all forest and tree planting practices.

2:45 <u>CAST 2021 Workplan Recommendations and Related Updates</u> – Loretta Collins, UMD/ AgWG Coordinator (30 min.)

Loretta Collins, UMD, will go over final updates of the CAST-21 Workplan. Issues not fully addressed by the partnership-established deadlines for updating CAST-21 may be applicable to future versions of CAST. Agreement about what will be included and excluded from CAST-21 depends on votes of members of the workgroups and WQGIT. Approved data and method changes for CAST21 need to be finalized through the WQGIT by Sept. 1, 2021.
