CBP regularly receives requests to review and potentially approve innovative practices as BMP's that can be implemented, tracked, and reported for load reduction credit towards the Bay TMDL. These requests can be handled through the BMP Expert Panel Protocol approved by the WQGIT in 2015.

In response to state partner inquiries regarding verification of BMPs and opportunities for reporting Resource Improvements (RIs) for credit towards nutrient and sediment load reduction, Jason will discuss Maryland's approach to BMP verification and incorporating CBP partnership-approved RIs into their progress reporting.
