10:15 AM **Boat Pump-Out Facilities BMP** -- Tanya and Ning Zhou (CBPO)

Since the last meeting, the City of Virginia Beach submitted a response to comments received on their proposal to consider Boat Pump-Out Facilities in No Discharge Zones as a BMP for credit in the Bay Program's modeling tools. The WWTWG must now determine how this new loading source could be included in the model and whether or not to endorse the formation of a BMP expert panel to evaluate this practice.

Decision Requested: WWTWG members will determine how this new loading source could be included in the Bay Program's modeling tools and whether or not to endorse the formation of a BMP expert panel.

10:45 AM <u>Point Source Data Project - Update and Stakeholder Outreach</u> – Laura Free, EPA

In March, Laura introduced a project aimed at documenting the current process for receiving and correcting point source data that is fed into the Bay Watershed Model. She will update the WWTWG on findings, share a framework for beginning conversations with each jurisdiction, and accept feedback on the overall framework. Each jurisdiction will have time to voice their unique concerns in separate, individual conversations.

11:10 AM BMPs for Small Onsite Systems Proposal – Marcia Degen, VDH

Marcia will lead a discussion on how to obtain credit for onsite systems that do not fall under current BMP definitions, but which are monitored to verify compliance.

Decision Requested: WWTWG will decide whether the workgroup should move forward to provide recommendations on the monitored onsite systems, or whether the workgroup needs further information and discussion on this issue.

11:40 PM <u>Rapid Infiltration Basins</u> – *Ning and Greg Busch, MDE*

Workgroup members will continue to discuss, and seek to reach consensus on a path forward for considering Rapid Infiltration basins for inclusion within the Chesapeake Bay Program's suite of modeling tools.
